Pune, 22 February, 2016

Thermax has received an order worth Rs.353 crore from Rashtriya Chemicals and Fertilizers Limited (RCF) to execute an energy efficiency improvement project.

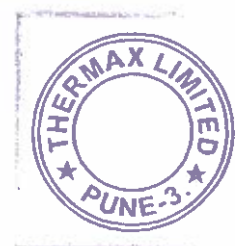
Thermax will commission a 50 MW gas based co-generation plant at RCF's facility in Thal (Maharashtra) for captive power. It will also install waste heat recovery boilers downstream of the turbines to provide required steam for process.
