#### E-voting

Members of the Company are hereby informed that pursuant to Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015, the Company has sent on July 12, 2018 a separate e-voting communication with login ID and password to the Members whose addresses/e-mail IDs are registered with the Company or provided by the Depositories, along with the 37<sup>th</sup> Annual Report and Notice of the AGM.

The Company has engaged the services of Karvy Computershare Pvt. Ltd. (Karvy), to provide e-voting facility to the Members of the Company.

The Company has appointed Mr. S.V. Deulkar, Partner of M/s. SVD & Associates, Practicing Company Secretaries, Pune, as the Scrutinizer to scrutinize the e-voting process in a fair and transparent manner.

The e-voting period commences on Friday, August 3, 2018 (9.00 a.m.) and ends on Tuesday, August 07, 2018 (5.00 p.m.). During this period, the shareholders of the Company may cast their vote electronically. The e-voting module shall be disabled by Karvy for voting thereafter. Once a vote on a resolution is cast, the member shall not be allowed to change it subsequently. Please note that any electronic votes received/cast by the Member(s) after August 7, 2018 (5.00 p.m.) will be strictly treated as if no reply from Member(s) has been received. A member holding more than ten percent of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as a proxy for any other person or shareholder.

Company is pleased to offer e-voting facility as an alternative mode of voting which will enable all the Members to cast their votes electronically on the resolutions mentioned in the Notice of the 37<sup>th</sup> Annual General Meeting (AGM) of the Company. Necessary arrangements have been made by the Company with Karvy Computershare Pvt. Ltd. ('Karvy'), to facilitate electronic voting (e-voting). Members who have cast their votes by e-voting prior to the AGM may attend the AGM but shall not be entitled to cast their votes again. The facility for voting through ballot paper will also be made available at the AGM and the members attending the AGM, who have not already cast their votes by e-voting, shall be able to exercise their rights at the AGM through ballot paper. 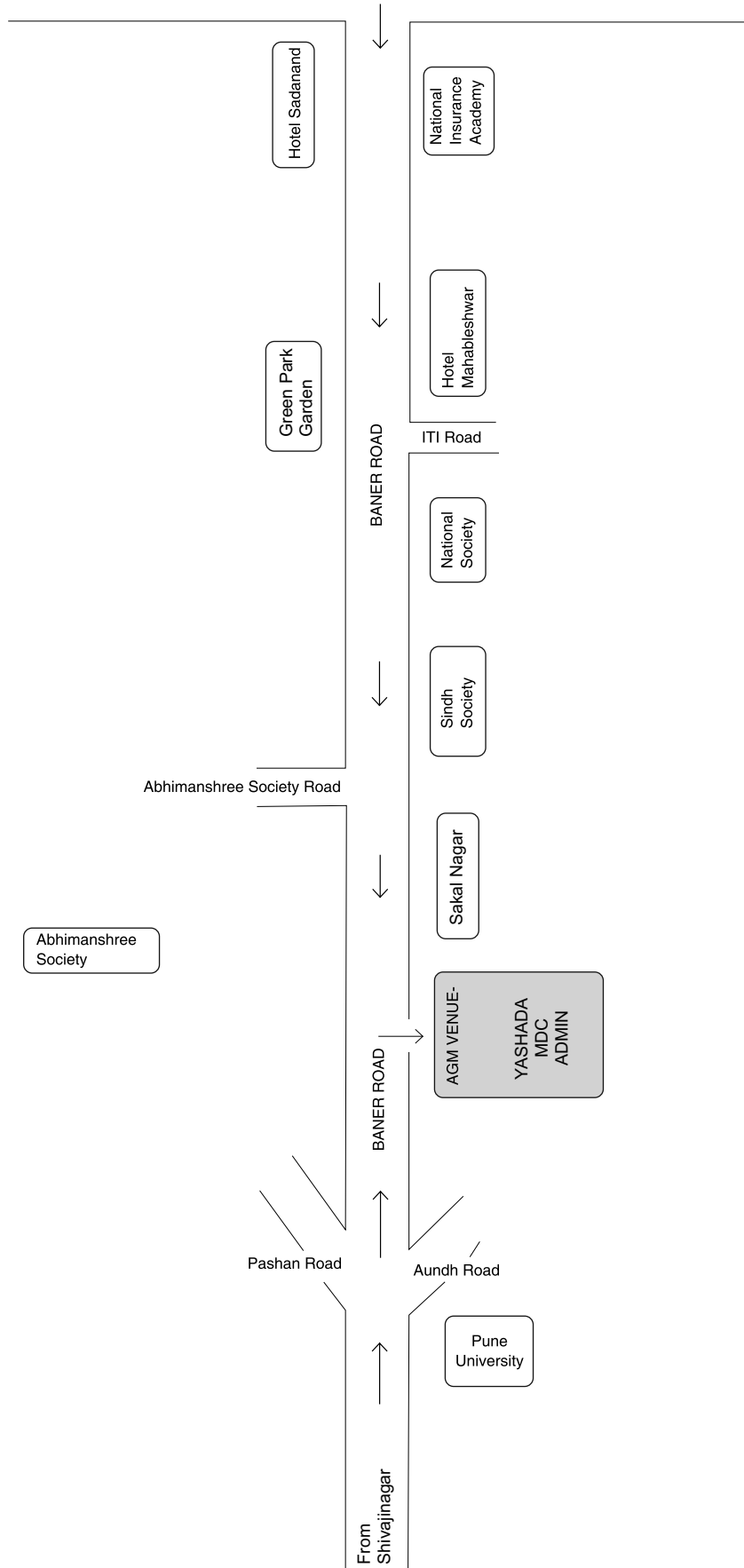
