Thermax wins Rs. 327 crore order for a co-generation power plant

Pune, January 1, 2018

The Thermax Group has concluded an INR 327 Crores order from a public sector company based in Western India for its up-coming chemical plant. The project is for a BTG (Boiler-Turbine-Generator) package on EPC basis for their captive co-generation power plant of 2x65 MW capacity

“Co-generation will continue to play a critical role in providing optimal energy solutions to Indian industry where both power as well as steam will be needed to support the processes.
